





ATM provider will levy a Monthly Maintenance Service (MS) charge of ₹5,000 per month.

## Waiver Conditions

- The MS charge will be waived for the first sixty (60) days from the date the ATM becomes cash live.
- The ₹5,000 MS charge will also be waived for any calendar month in which the total number of cash transactions exceeds 2,400.
